## 1. Description

Rallysprint "Gulbis 2016" will be run in compliance with Latvian Automobile Federation (LAF), LAF National Sporting Code General Part, Regulations of LAF Standard Automobile Commission (SAK), LAF SAK Technical Regulations and its Appendices, as well in Latvia valid Street Traffic law, Regulations of Lithuanian Rallysprint Championship and Regulations of this Rallysprint "Gulbis 2016".

Modifications, amendments and/or changes to these Regulations will be announced only by numbered and dated bulletins issued by the Organizer or the Stewards. These Regulations are published in Latvian and English.

### 1.2. Forbidden Territories

It is forbidden for drivers, entrants and its representatives to drive from 06.07.2016 till 06.08.2016 on roads indicated in the Rallysprint route scheme (Appendix Nr.4), except persons with written permission of LAF SAK commission or Organizer. Any infringement of this Regulation will result in fine penalty - 700 EUR.

Each repeated offence will imply exclusion from Rallysprint.

### 1.3. Route

Rallysprint will take place on 6 August 2016 in district Gulbene.

- Number of Special Stages 6
- Total distance of Special Stages till ~45,72 km
- Shortest Special Stage till ~4,70 km
- Longest Special Stage till ~10,79 km
- Total rallysprint length till ~186,36 km
- There will be in the Rallysprint 1 Leg with 2 sections.

All Special Stages – speed run.

All Special Stages in the Minirally Cup – regularity run.

### 1.4. Rallysprint road surface

SS 1;2;3;4;5;6 gravel.

Exactly total length of the Rallysprint and length of Special Stages the competitors will get together with the Road Book.

## 4. Entries

### 4.1. Closing date for Entries

Closing date for Entries with standard Fee is Monday, 25 July 2016, 18:00 hrs.

Closing date for Entries with increased Fee is Friday, 29 July 2016, 18:00 hrs.

### 4.2. Entry procedure

The competitor must complete the Entry form on the web site [www.4rati.lv](http://www.4rati.lv). It is possible to specify the information about the co-driver during the Administrative Checks. Signing the Entry the competitor allows the Organizer to publish the information contained in the Entry in the Mass Media.

Participants who has sent the Entry form to the Organizer but can't participate in the Rallysprint must inform the Organizer about it before Tuesday, 2 August, 2016. Otherwise this will be reported to the LAF Standard Car Committee who will consider a penalty.

**The participants must compulsory indicate in the Entry Form classification group want to participate.**

### 4.3. Competitors Licence

To take part in the Rallysprint both the driver and co-driver must hold a Competition license according to the Latvian Rallysprint Championship Regulations 2016.

### 4.4. Classification groups in the Rallysprint "Gulbis 2016":

#### 4.4.1. Latvian Rallysprint Championship:

<b>1600</b>	Cars with single axle drive up to 1600 cm <sup>3</sup> . The cars are prepared according to LAF SAK Rallysprint Technical Regulations.
<b>4 WD</b>	4-wheel drive cars only with aspirated engines up to 3000 cm <sup>3</sup> – (overpressure of the engine air intake is not allowed). The cars are prepared according to LAF SAK Rallysprint Technical Regulations.
<b>2 WD Open</b>	Cars with single axle drive over 1600 cm <sup>3</sup> . Includes classes: L9, L10, L11, L12, L13, L14, N1, N2, N3, A5, A6, A7, R2, R3. The cars are prepared according to LAF national or FIA international groups Regulations.
<b>4WD Open</b>	4-wheel drive cars up to 4000 cm <sup>3</sup> , overpressure of the engine air intake is allowed. Includes classes: L9, L10, L11, L12, L13, L14, N4, A8, R4, S2000, WRC. The cars are prepared according to LAF national or FIA international groups Regulations.

<b>Cup of Classics</b>	In the Championship there will be organised the Cup of Classics for rear-wheel drive cars with engine and transmissions position on the front of the car. It includes classes: Classics 3000, Classics VAZ. Competitive cars must be prepared in accordance with the LAF SAK Classics Cup Technical Regulations.
<b>Minirally Cup</b>	Includes all classification groups in accordance with Minirally Cup 2016 Regulations for standard cars, Art. 1.2.

In the Championship will be organized parallel to the classification groups the “**Junior Cup**” competition – for 1991 born and younger drivers with “1600” and “2WD Open” group cars with one axle drive.

#### 4.7. Refunds

Entree Fee will be refunded:

- in case of the Rallysprint not taking place because of Organizers` fault – 100% refund;
- in case of the Rallysprint does not take place due to force majeure – 75% refund;
- to candidates whose entry has not been accepted – 100% refund;
- if the participant can't participate due to force majeure acknowledged by the ASN – 25% refund.

## 5. Insurance

### 5.1. Insurance

#### 5.1.1 Organizers' liability insurance

The Organizer have entered into a contract of insurance with the AAS “Baltikums Vienna Insurance Group” AAS on the Organizer`s responsibility against damage incurred by third parties during the race. Insurance policy is valid from 6 August 2016, 07:00 hrs to 6 August , 21:00hrs.



### **5.1.2 Damage to third parties**

As part of the contract of insurance with “Baltikums Vienna Insurance Group” AAS is car insurance for damages caused to third parties. However, this agreement does not cover damage caused by the incident caused.

### **5.2. Car insurance of civil liability**

All crews have to hand in at Administrative Check a valid International Green Card or OCTA policy. Without this Green card or OCTA policy crew would not be permitted to start.

### **5.3. Insurance coverage for the competitors and crews**

All the drivers and co-drivers are obliged to arrange their own life accident insurance. The proof should be documented on request at Administrative Check. By the fact of signing the entry form, the competitors and/or drivers relinquish any claims to compensations of any kind which might result due to incidents. The relinquishment is applied to FIA, ASN, the Organiser, Officials and other competitors and/or drivers.

Drivers and co-drivers who are not from the EU, must have concluded travel insurance contracts contain active recreation risks.

### **5.4. Damage reporting**

The crews are obliged to notify the Organizer about any damage caused by their car by the end of the event the latest. Violation of this duty stands for summoning the competitor and involved crew to the Stewards.

### **5.5. Insurance coverage exclusions**

Auxiliary vehicles, reconnaissance cars, cars with special Organisers` labels and cars with Officials stickers are not covered by the provided competition insurance (with the exception of insured Organisers` cars) and those are always going on their own responsibility.

### **5.6. Damage coverage exclusion**

The Organizer refuses from any liability for damage that has been caused by a participant due to unfair action either regarding the rally regulations and these Supplementary Regulations or the State Law. In case of a road traffic accident neither a service car, or a reconnaissance car and an official`s car with rally markings are considered as crews of the competition. In these cases only car owner third-person`s liability insurance policies are valid.

## **6. Advertising and Identification**

### **6.1. Advertising**

Competition numbers, Rallysprint plates and Organizers` advertising plates must be affixed on the car before the Scrutineering according to the Appendix Nr. 2.

### **6.2. Advertising loss or relocation**

Violation of Art. 6.1 will be penalized with a refusal to start. For advertising sticker shape or size variation without Organizers` agreement the crew will be penalized with 50 EUR fine for every lost and/or modified, or not in accordance with Appendix Nr. 2. attached advertising.

Competitors are allowed to place on a car any advertising in accordance with the regulatory requirements.

Identification of participants must be located on the car in accordance with regulatory requirements.

### 6.3. Identification and Rallysprint plates

Identifications and competition plates issued by the Organizer must be located on the both front doors of the car throughout the competition. If it is found that during the competition at any location:

- one start number or Rallysprint plate is missing, it will be penalized with 100.00 EUR;
- both start numbers or Rallysprint plates are missing, it will be reported to the Stewards.

## 7. Tyres

### 7.1. Tyres permitted during the event

It is permitted to use the tires in accordance with the Latvian Rallysprint Open Championship 2016 requirements of Regulations.

### 7.2. Tyres permitted during the Reconnaissance

It is permitted to use during the Reconnaissance tyres in accordance with Latvian Road traffic rules with summer tread.

Any infringement of this rule will be penalized with – 150 EUR.

## 8. Fuel

### 8.1. Refuelling

Refuelling will be carried out in special refuelling zones. For safety and environmental protection reasons during refuelling liquid proof mat has to be used.

Penalty for non-compliance is 50.- EUR.

Only crew members and their support personnel are responsible for compliance with fire safety regulations during the refuelling.

## 9. Reconnaissance

### 9.1. Registration procedure:

When registering for the Reconnaissance the competitor must provide the Organizer with the information about details of the reconnaissance car, mobile phone number and accommodation. The Organizer must be informed in time about any replacement of the car. If the crew during Reconnaissance for some reason are forced to change the car, the Secretariat must provide detailed information on the new car.

**The participants will get Reconnaissance TC. It must be returned after the Reconnaissance in the Rallysprint HQ, Kļavu str. 30, Gulbene, 6 August before 13:00 hrs.**

The Reconnaissance numbers must be affixed to the recce car on the windscreen (top on the right) and kept visible for the whole duration of the Reconnaissance period.

### 9.2. Schedule

Reconnaissance Schedule is given in addition to the Rallysprint Supplementary Regulations Appendix Nr.5.

#### 9.2.1. Number of persons on board

During each passage on a Special Stage, a maximum 2 persons (the crew) are permitted in the car. For any deviation from this point a crew must inform the Clerk of the Course before the closing date of Entry.

### 9.3. Reconnaissance Regulations

#### 9.3.1. Speed limit

All reconnaissance on the Special Stages has to be done at reasonable speed in accordance with Latvian traffic rules. The maximum speed set for the reconnaissance on the SS is 80 km/h, except for those areas in which there are speed limit signs or in built - up areas (50 km/h or 30 km/h) or other limitations marked in the Road book.

### 9.3.2. Direction

It is not allowed to drive in the opposite direction of the Rallysprint on the Special Stages. The crews must always enter and leave the Special Stage through the start and stop controls.

### 9.3.3. Restriction of Reconnaissance

Any driver, or his co-driver, who has entered or intends to enter the Rallysprint and who wishes to drive after 6 August, 2016 on any road which is or might be used as a Special Stage in this race, may only do so after he has obtained the Organizer's written permission. This shall not apply when the person is known to live along the specific road. Failure to respect this rule shall result in the driver being reported to the Stewards.

### 9.3.4. Number of passages

Reconnaissance is permitted max. 2 passages in each Special Stage. **As an exception, 3 passages are permitted for drivers below 19 years of age** (Special Stages run twice are considered to be one Special Stage).

### 9.3.5. Illegal reconnaissance

Illegal reconnaissance performed out of the Time Schedule or performing more passages than permitted will be reported by the Stewards. Participants who fail to comply with other reconnaissance rules, will be penalized as follows:

1<sup>st</sup> infringement – it will be reported to the Stewards;

2<sup>nd</sup> infringement – 5 minute penalty;

3<sup>rd</sup> infringement – it will be reported to the Stewards.

### 9.3.6. Speed Infringements

Penalties for infringements in **any place** during the reconnaissance concerning speed limit is following:

1 <sup>st</sup> infringement 10 - 20 km/h: fine – 15 EUR for each km/h over the speed limit;
1 <sup>st</sup> infringement 20 - 40 km/h: fine – 20 EUR for each km/h over the speed limit;
2 <sup>nd</sup> infringement 10 - 40 km/h: fine – 20 EUR for each km/h over the speed limit;
3 <sup>rd</sup> infringement or over 40 km/h: will be reported to the Stewards.

### 9.3.7. Radar detection equipment

The fitting or carrying of radar detection equipment during reconnaissance is not permitted.

- technical passport and sports technical passport of the car;
- homologation form.

## 11.3. Regulations

Competitors or their representatives must have made the necessary preparations before going to the Scrutineering. Start numbers, Rallysprint plates and Organizer`s advertising must be affixed on the car in accordance with the Appendix Nr.2 of Regulations correctly before the Scrutineering.

Drivers safety equipment will be checked at the Scrutineering also.

Each competing car must be equipped with a first aid kit and 2 reflecting triangles, under pain of refusal to start.

## 12. Other procedures of the Rallysprint

### 12.1. Official time of Rallysprint

Official time throughout the Rallysprint will be visible in the HQ of Rallysprint.

### 12.2. Start procedure and order

#### 12.2.1. Start

The cars will start on Sunday, 6 August, 2016, at 13:00 at Gulbene Regional Council, Ābeļu str. 2. The Start order will be published at Official Notice Board (according to the Rallysprint Programme).

**All penalties for pre-start infringements must be paid before August 6, 2016, 13:00hrs. Otherwise, it will be reported to the Stewards.**

Start interval between crews throughout the Rallysprint will be 1 minute.

#### 12.2.3. Start procedure for Special Stages

Start procedure for Special Stages will be as follows:

- On the start position the crew stops when instructed by marshals;;
- When the start marshal confirms the car is on the right start position – 40 cm before electronic controlled start line the car must stay immovable till start moment and the team must visual follow the light signal of light shield;
- On the light shield the time will be shown;;
- 30 seconds before start the marshal passes to co - driver the Time Card;
- 30 seconds before start on the shield will be shown the remainder seconds till start;
- The last 5 seconds of the pre - start minute are marked with five red light signals. When all signals go out, the road for start is free;
- If the crew`s car cross the electronically controlled start line before red lights are going out, automatically will be fixed false start which will be indicated with 5 seconds delay;
- Final decision about false start makes the start marshal by making a note in the start protocol;
- If the start system does not function, start will be given by a marshal in

- accordance with the LAF Rallysprint regulations.

#### 12.2.4. Early check in

Crews are authorized to check in early without incur a penalty at following Time Controls:

- TC 7

#### 12.2.5. Regrouping

After section 1 the Regrouping will be arranged to set up new starting time for crews to fill up starting time of retired crews, but without change of succession of start. But the Stewards can decide about order change of separate crews.

#### 12.2.6. Withdrawal procedure

If a driver is involved in an accident in which a member of the public sustains physical injury, the driver concerned must report to the next radio point as specified in the Road book and signposted on the route and inform about the accident the following drivers and use red „SOS” sign. If he fails to observe this regulation, the Stewards may impose a penalty which may go as far as exclusion. If a crew stops on SS for any reason and cannot continue the race or an accident is occurred without wounded, who need medical aid, the driver must show clear „OK” sign for next three crews.

If a crew retire, he must note in the Time Card reason of retirement and return the Time Card to closing car “Green Light” who is equipped with glittering signal lights and follow after the last competitor. Penalty for infringement of this demand - 70 EUR.

In a case of an accident or technical failure on the Special Stage when the competing car is on the road or less than 3 m from the road the driver must warn other competitors by placing emergency signs of not less than 100 m from the accident place on visible side of the road where the crashed car stands.

The competitors, who retire from the race because of an accident, must show **obligatory** the car the Scrutineer before the Prize-giving. If it isn't possible, the competitor must agree with the Scrutineer about checking after the competition. In accordance with the resolution of LAF SAK Council penalty for an incorrect indicating of retirement reason in the Time Card – prohibition to start in the next competition.

**The reason of retirement must be reported to the Rallysprint HQ per Tel.: +371 26605605.**

#### 12.2.7. Finish procedure

The competition ends at arrival TC zone TC 7, Robežu str., Gulbene, 17:10 hrs. After finish the competitors have to follow the instructions of Official to go to the Park Ferme.

### 12.3. Barriers

Because of safety reason there will be on the Rallysprint route barriers of track tyres.

### 12.4. Service procedures

A limitation for servicing, refuelling and changes of mechanical parts is introduced in the LAF SAK Rallysprint General Regulations. Service parks can be entered only by one Service vehicle with service plate (SERVICE). A fee for an additional car sticker (SERVICE) is 50.00 EUR / pcs with 21% VAT (included).

## 12.5. Allocation of working areas

Competitors will be provided with working areas for one crew inside the Service Park as follows:

$$6\text{m} \times 9\text{m} = 54 \text{ m}^2$$

## 12.6. Speed limit

Maximum speed in the Service Park may not exceed 30 km/h. Crews will be penalized by the Stewards for over speeding.

## 12.7. Behaviour within the Service Park

Only competition vehicles and service vehicles with affixed service plates „Service,, which is affixed to the corresponding car windscreen, (issued by the Organizer) are allowed to enter into the service area. Damages of the surface of the Service Park have to be avoided. Nails and screws for fixing on the surface of Service Park are not allowed. For damages at the service area assigned to the crew, the crew is liable. Crews are obliged to put a sufficiently large plastic ground sheet under the competition vehicle as long as service works are carried out. No sustainable and avoidable damages shall be caused because of service works. Refueling is allowed only at the foreseen refueling zone. After the Rallysprint the service park has to be handed over in tidy condition. Crews are responsible for the removal of their waste and sewage.

## 12.9. Entrance to the Regrouping area and Park Ferme

### 12.9.1. TV teams

TV teams, which will be published by the Clerk of the Course information, are allowed to enter the Regrouping area and Park Ferme in order to maintain the camera systems installed in the race cars or to exchange the data recording media. They have to be accompanied by Scrutineer and the representatives of the teams (driver, co-driver or competitor).

### 12.9.2. Crew

In the Regrouping zones 3A the crews are allowed to own cars.

Appearance of the winner to the Prize-giving obligatory. Absence from Prize-giving, the crew forfeits the prize.
